If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Minimize dust generation and accumulation. Avoid the generation of dusts during clean-up. Prevent entry into waterways, sewer, basements or confined areas.
