## 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Do not use mouth-to-mouth method if victim inhaled the substance. Oxygen or artificial respiration if needed. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician if symptoms develop or persist.
