4. First-aid measures

6. Accidental release measures

Methods and materials for containment and cleaning up

Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Prevent entry into waterways, sewers, basements or confined areas.
