4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage. Causes serious eye damage. May damage fertility or the unborn child. Corrosive Liquid. Avoid contact with skin, eyes, and clothing. Avoid breathing vapor. If swallowed, do not induce vomiting. Dilute with water and call a physician. Wash areas of contact with plenty of water. Potential symptoms of overexposure are irritation of the eyes, mucous membranes and skin, dental erosion, bronchitis, pneumonitis, delayed pulmonary edema. Mercury compounds affect the kidneys and central nervous system. Contains a material known to the state of California to cause reproductive toxicity. 
