4.1. General First Aid Information

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause severe burns and permanent damage.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage. Causes serious eye damage. Mildly corrosive liquid! May cause burns to all areas of contact. May be fatal if swallowed. Wash areas of contact with water immediately for at least 15 minutes. Inhalation can cause coughing, choking, inflammation of the nose, throat and upper respiratory tract. If ingested, give large quantity of water. Do not induce vomiting. Call a physician immediately. EYE CONTACT: May cause severe burns and permanent damage. SKIN CONTACT: Can cause redness, pain and severe skin burns.

4.3. Medical Attention or Special Treatment Needed

Immediately call a POISON CENTER or physician. Specific treatment (Wash areas of contact with water immediately). Irrigate immediately with large quantity of water for at least 15 minutes. Call a physician if irritation develops. Remove to fresh air. Give artificial respiration if necessary. If breathing is difficult, give oxygen. Flush with plenty of water for at least 15 minutes. Cover the spill with Sodium Carbonate or a soda ash-slaked lime mixture (50:50). Mix and add water to form slurry. Decant the liquid to the drain with excess water. Treat the solid residue as normal refuse. Wash site with soda ash solution. Always dispose of in accordance with local regulations.

SECTION 7: Handling and Storage

7.1. Precautions for Safe Handling and Storage Conditions

Store in corrosive resistant container with a resistant inner liner. As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Do not mix with bases.

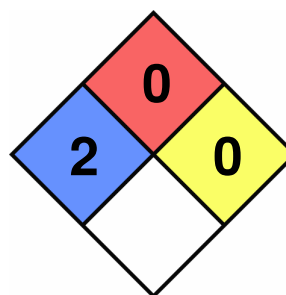
